

"REAL ID" advisory from HOA County Liaison and Neighborhood Watch. The "REAL ID" card just became available on July 1, 2019. As you are aware on or before 10/1/2020 you will need a "REAL ID" card to board airline flights, enter federal buildings, nuclear facilities, or military bases.



Suggested locations to obtain your "REAL ID" card follow:

(1) Maryville Driver Services Center, Address 318 Home Avenue, Maryville, TN 37801

Days and Hours of Operation, Monday - Friday 8:30 a.m. to 5:00 p.m.

Tip: Go to an available Kiosk, start the process and when prompted scan a credit card. You are now electronically in line and have expedited your "REAL ID" processing time. The average wait time is about 30 minutes.

- The Loudon County Clerk's office cannot process "REAL ID" cards at this time. Villagers that live in Loudon County should go to Maryville Driver Services Center until the Driver Service Center is available in Loudon County sometime in the first quarter of 2020.
- Villagers that live in Monroe County can also go to the Maryville Driver Services Center for faster processing times

(2) Monroe County Clerk's Office, 103 College Street South Suite 1, Madisonville, TN 37354

Driver's License renewals and duplicates are processed, Monday - Friday from 9:00 a.m. to 4:00 p.m.

Note: Recent applicants have experienced 30 minute up to 2-hour wait times for "REAL ID" processing.

At all Driver Services Centers or County Clerk Offices you need to bring the following in each category with you.

- Category 1. (1) Proof of Citizenship: A birth certificate, valid Passport, or other proof of legal residence.
- Category 2. (1) Proof of Social Security Number: A social security card, W-2 form, 1099 form, or payroll stub.
- Category 3. (2) Proof of TN Residency: You Need 2 of these. Must show and document the applicant's address.

Current driver's license, vehicle registration, Insurance card, utility bill, receipt of property tax bill, Homeowners Insurance Policy, etc. Please view the details about required documents for "REAL ID" processing on page 2.

When: Obtain your "REAL ID" card on or before 10/1/2020

Where: Maryville: Driver Services Center Monday - Friday 8:30 a.m. to 5:00 p.m., Madisonville: Monroe County Clerk's Office Monday - Friday from 9:00 a.m. to 4:00 p.m., Loudon County Clerks 'Office expected availability (Q1-2020).

Expedited Processing in Maryville: Go to an available Kiosk, start the process and when prompted scan a credit card.
