### Advocacy

The March HOA Open Village Meeting (which was cancelled) was to include a presentation from the turf grass experts at the UT Knoxville Institute of Agriculture on lawn care practices in East Tennessee. Since we're now starting into the lawn care season, I thought I'd pass along to you some of the recommendations that they were planning to give.

In general, while the grass you now have may be similar to whatever you had in the place you moved from, the climate and soil are not the same here. It is worthwhile rethinking how you take care of your lawn here in Tellico Village to get the best results. The benefits of doing so are reduced water use and fungal disease, improved water runoff control, and lower costs to maintain your lawn overall.

# New Speed Limit on Tellico Parkway

TDOT has announced that they will be lowering the speed limit on the south end of Tellico Parkway from 50 mph to 45 mph. The lower speed limit will begin at the Clear Creek Bridge and continue south for 1.5 miles to the intersection with State Route 72.

The reasons for lowering the speed limit include: increased accidents at Chatuga Dr. and Mialaqua Rd intersections, the number of deer strikes, increased traffic from the Neighborhood and Senior Living areas, and commercial traffic on the south end of the Village.

The new speed limit signs are currently being installed.

August 6th is the date for State and Federal Primary and Local General Elections in Loudon and Monroe Counties. The following are the dates for your use.

It is extremely important that we as a community vote in this and all elections. Voter turnout from this community is one of the key factors our elected officials use to decide how to deal with issues directly affecting Tellico Village and surrounding community.

- May 8th, First Day to request Absentee Ballots (Military and Overseas).
- July 7th, Last Day to register to vote.
- July 17th First day of early voting.
- July 30th, Last day to request an absentee ballot.
- Aug. 1st, Last day of early voting
- August 6th, Election Day
