Introducing Loudon County Commissioners

Last month the Voice introduced Loudon County government in an article that described the Loudon County Commission and the other officers that participate in county departments. At the end of the article I promised a follow-up to introduce the Commissioners in Districts 1 and 7 who work with the residents of Tellico Village. This is their story!

INTRODUCING HENRY CULLEN

Before we share Henry's thoughts on Loudon County and Tellico Village issues, let's take some time to meet him

- A Tellico Village resident since 2003 the Cullen's moved here from Atlanta, Georgia.
- Henry and Cathy, who have known each other since grammar school, are parents of 3 sons and grandparents of 2 grandsons and 2 granddaughters.
- Henry is an ex-Ford man with experience in sales, marketing, and customer service.
- Henry, who is an advanced EMT, was the Tellico Village fire chief from 2004 2012. He is proud of
 developing the model that turned our fire department into a respected organization in the village.
- Henry ran for Loudon County Commissioner in 2014 at the suggestion of many residents of the county. Commissioners are elected by the residents of their district every 4 years.
- After winning a second term as commissioner in 2018, Henry was elected Commission Chairman by his peers for one-year terms in 2018 through 2021.
- For fun well besides being a Loudon County Commissioner Henry enjoys boating, travel, and first and foremost time with his grandchildren.
- Henry agrees with other residents of Tellico Village who say they moved to TN to 1) enjoy life, 2) gaze at the beautiful scenery, and 3) get a raise in income through Loudon County's low taxes.

Henry's thoughts -

- Since Henry's 7th District is comprised of Tellico Village (all but the far northern section), Henry feels
 that his 17 years in the Village give him not only a past, present, and future perspective on Village
 issues, but also his government experience has contributed to an in-depth knowledge of TN state,
 county and local government process.
- Henry counts as his biggest accomplishments in serving as a Loudon County Commissioner the following –

- 1) Serving as vice-chairman of the County Budget Committee where during his time the property tax rate has not increased, the budget has remained fiscally conservative with a healthy fund balance, and funding from the county to the Tellico Village library and fire department and Smoky Mountain Service Dogs has increased.
- 2) Henry is proud of his important role in negotiating the sale of 430 tax delinquent lots from Loudon County to POA of Tellico Village.
- 3) While participating on Loudon County's committee for the new jail, Henry assisted in the decision-making that brought the jail to completion with no tax increase for Loudon County residents.
- 4) To highlight a current issue Henry is proud that the Loudon County conservative budget, created by the county budget committee and approved by the Commission, has remained solvent and healthy even with the income decrease necessitated by COVID-19 restrictions.

Henry emphasized these important issues that need action by the Loudon County commissioners and their chairman –

- 1) Completion of the Loudon County courthouse repairs and rebuild
- 2) Continued economic growth for Loudon County
- 3) Education of Tellico Village residents regarding what Loudon County can and cannot do for Tellico Village since the Village is a private subdivision. For a starter It is illegal for Loudon County to give public funds (property tax income) to a private entity (Tellico Village).

Wed. Dec. 16th: December Board Meeting - Certification of Election Results and Announcement of new Board members.

THE POA BOARD CANDIDATES FORUM WAS HELD THURSDAY, OCTOBER 22ND

During the forum, the audience got a chance to meet the three candidates running for the two open POA Board positions: Pat White, Mike Blackwell, and Rick Blough.

The event was broadcast live by TVB from the 5th floor of the Yacht Club. In addition, seating was available on the lower level to watch the event live on a big screen. All viewers and attendees were able to submit questions during the live broadcast using CHAT.

The candidates introduced themselves, explained why they were running for the board and were the best candidate for the position. Prior to their introductions, Mitzi Lane, COO of Tellico Village, explained the POA Board responsibilities and expectations, and why the board positions are so important to Tellico Village.

The candidates then answered prepared questions in nine categories. In addition, some questions from the audience were also addressed. The following audience questions were not able to be answered due to time constraints:

- Do you support obtaining a professional reserve study that documents the anticipated lives of ALL our components, estimates the repair/replacement costs, prepares a 30-year funding plan
- If yes to a reserve study, would you support a separate reserve fund that protects the reserve monies from being used for other purposes.
- As a POA Board member, what new amenities do you envision will attract future residents to our community?
- How can we the people of Tellico Village promote the election of village members to county board seats to present our positions here within our village

These questions are being submitted to the candidates by the HOA, requesting a written reply. Once we have received their responses, we will publish them in a future edition of the HOA Voice.

Your HOA wants to thank the candidates and presenters for agreeing to participate in the forum and their thorough preparation. We also want to thank the TVB team and many volunteers who helped put on this event.
