

### **Update to Members Concerning Postings on Next Door and Other Social Media**

These are certainly unusual times we live in. With the rise of social media anyone can instantly post their thoughts and reactions to events – as they perceive them. Sometimes these postings by individuals either don't have or don't present all the relevant information - and even if later retracted may not be seen by all and leave a lasting wrong impression.

There has been a recent situation where such an event happened which unfairly cast the HOA and Golf Coordinators as doing something wrong. You may have seen this or been asked by others and wondered what actually happened. Rather than responding on Next Door, we decided not to make too much of this and possibly reopen further discussion – but thought our membership would like to be made aware of the entire story.

So, what was this incident that happened? As part of our normal golf rotation, HOA Golf held a special golf event at Kahite which included bringing in a Taco Food Truck since the event was being held on May 5th – Cinco De Mayo. This same food truck had been used before at Tanasi for other POA Golf Events with absolutely no issue. HOA representatives were concerned about overwhelming the Pub staff with a large group of golfers arriving at the same time for dinner. With the Taco Truck being a good option, at least a month prior to the event, the HOA Golf committee met with the Kahite Pub Manager about having this food truck and in fact, worked out a special Mexican food-themed drink/food combo to be offered to attendees since no drinks were to be provided by the food truck. The food truck sold only food while all beverages were provided through the Pub - each party was being accommodating to the other.

At some point after HOA booked the event, due to the special occasion of Cinco de Mayo, the Pub Staff subsequently planned a taco special for their other patrons. This caused confusion among some residents, as it appeared that the HOA was competing with the Pub by having a food truck. Unfortunately, rather than asking HOA for comment and clarification, the HOA and the Event Coordinators were the subject of emails and Nextdoor postings condemning the wisdom of our actions and questioning HOA leadership in support of POA Kahite facilities.

Frankly, HOA Golf was blindsided as they thought they had conducted a successful event benefiting all parties involved. HOA Golf had only good intentions to provide an excellent experience for their golfers while also supporting the Links at Kahite and the Pub.

While the comments were somewhat retracted and the posting taken down, damage was already done to the feelings of many HOA volunteers as well as leaving questions in the minds of some residents – hence this message today to set the record straight.

Going forward we would kindly request that concerns anywhere in the Village about HOA events or activities be directed first to HOA for a response before resorting to social platforms and rumor mills.

Most importantly, and sometimes this is forgotten, the HOA consists entirely of volunteers and we want to thank them for doing their best through difficult times to support the homeowners of Tellico Village - providing social events but also advocating and providing information on topics that impact all residents.

#### **Highway Safety Committee Report**

TDOT has recently completed the refurbishment of the bridges on Tellico Parkway. This is the most recent of many highway improvements over the last ten years that benefited Loudon County in general and Tellico Village in particular. TDOT spent \$110,000,000 in new road construction for these improvements including \$75,000,000 for the Tn River Bridge, \$23,000,000 on the widening of 321 in Lenior City, \$10,000,000 for repaving of Tellico Parkway, and \$800,000 for refurbishment of Tellico Parkway Bridges.

Additionally, TDOT invests \$120,000 annually in the maintenance of Tellico Parkway for such items as mowing, tile replacement, downed trees, etc.

We want to thank TDOT engineers Todd Sexton, Joshua Metz, and Kristen Qualls. Also, we would like to thank Amanda Snowden, Region 1 Director of Operations. These TDOT employees were responsible for the completion of all these projects.

Also, thank you to our elected officials, Rep Lowell Russell, Sen. Randy McNally, and former Rep Jimmy Matlock, for their help in funding this work.

TDOT could have chosen to spend the money for these projects anywhere in the state, but they decided to spend the money here. We should all be thankful for their efforts on our behalf.

#### **Foothills Parkway**




**Foothills Parkway** is one of many scenic drives that is close by and easy to drive.

The southern end of Foothills Parkway is 17 miles long. It runs from US 129 at Chilhowee Lake to US 321 in Walland, in the Wears Valley.

There is a northern end of the parkway that is 5.6 miles long. It runs from I-40 south to US 321 at Crosby. This drive is not connected to the southern drive.
