#### Neighborhood Watch, Contractor Fraud

#### **Contractor Fraud**

Many Tellico Villagers are having work done this summer which increases the possibility of Contractor Fraud. We wanted to get this out to all of the villagers to help spot fraud.

Contractor fraud occurs when individual contractors or firms offer services that knowingly mislead the other party, such as performing unsatisfactory repairs or charging more than a job is worth, or in some cases – asking for a large down payment and never returning to do the work.

The following are common signs of contractor fraud and what you can do to avoid being scammed.

- <u>Advance Full Payment</u> If a contractor requires the full payment upfront, you should think twice before hiring them. It is not unusual for a contractor to request some money upfront, but you should not put a significant portion of the job down right away. Other payments should be made according to an agreed upon schedule as certain work is finished. Never pay a contractor in full or sign a completion certificate before the work is done to your satisfaction and you have confirmed it is compliant with local code requirements.
- 2. <u>Contractor Who Doesn't Pay the Supplier</u> You find out the contractor did not pay the supplier of the materials after you have paid them in full when the supplier comes after you for the cost of the materials. You can consider seeking a lien waiver from the contractor before the work begins. When the project is complete, both you and the contractor sign off stating that all contract obligations have been met. This includes the contractor making all the payments to the suppliers. If the contractor won't sign off on the lien waiver, you don't have to pay them until they have proven the suppliers have been paid.
- 3. <u>Full Credit for Your Deductible</u> It is illegal for a contractor to waive your insurance deductible or help you avoid paying it. One way of doing this is by giving you an estimate that is higher than the actual cost to make the repair. Another way is to offer rebates or credits in the amount of your deductible. Don't do business with a contractor that suggests this. It is fraud against your insurance company.
- 4. <u>Free Inspections</u> Most legitimate contractors offer no charge for an estimate, but you should always be wary. During the inspection, be extra attentive to the contractor's assessment and it is always a good idea to get more than one estimate.
- 5. <u>Out-of-State Contractors</u> There are contractors who will follow storm events from state to state. Hiring an out-of-state contractor can causes problems down the road. If they did careless work or didn't

complete the job, they will be difficult to track down. Or if a problem comes up later, you may have a difficult time getting them to come make corrections to the work. It is a better idea to go with a local contractor. You can check with the Better Business Bureau or ask within the community for references and recommendations.

- 6. <u>Poor Workmanship</u> Some contractors may use cheap materials or inexperienced workers to make a bigger profit. Obtain references and be diligent about researching a reputable contractor. Also try to be knowledgeable about some of the materials they will be working with.
- 7. <u>Unforeseen Problems</u> If a contractor reveals an unforeseen problem, be guarded. If a contractor points out a problem that you didn't hire them to fix, be sure to get a second opinion or do some research and make sure the problem needs immediate attention. Both you and the contractor should sign a contract before they begin work on it or charge you any amount of money.
- 8. <u>Improper Permits</u> A building permit ensures that your property was reviewed and inspected to meet codes, ordinances and requirements. When a contractor gets a building permit, they are ensuring their work is inspected and up to local code. If they don't have a proper permit, you could be liable for any problems or injuries sustained during the project. Also, if the contractor installs anything improperly and it later needs to be fixed, your insurance may not cover any expenses.
- 9. <u>Proper Licensing</u> If your contractor does not have a proper license that meets your state's requirements, you could be held responsible if issues arise during the project. Ask for the contractor's license which you can look up on your city or state's government website. If you work with an unlicensed contractor, you could be responsible for any problems that arise. For example, you could be financially responsible if the contractor or subcontractors cause any damage to your property, or if a worker is injured on your property. You could also be liable if your project does not meet local building codes.
- <u>Contract Agreements</u> A reputable contractor should be willing to provide a written contract that has everything you want and agree to. You and your contractor should sign a final contract that is read by both parties.
- 11. <u>Contractors Soliciting Business</u> Some contractors may use advertisements like flyers and door hangers to solicit business. This can be an honest, advantageous search for work, but be guarded and ask questions. It is good practice to contact your insurance agent prior to agreeing to work with any contractor in the situation when your insurance is paying for the work to be done.

If you are already a victim of contractor fraud, it may be in your best interest to get an attorney. An experienced real estate or contract attorney are usually your best options to help you. The best way to avoid contractor fraud is by making sure you do diligent research to find a trustworthy source. Trust your intuition and make sure you ask the right questions.

#### TellicoLife is the place to go for What's Happening in Tellico Village!

By having one electronic hub to connect Villagers with these organizations, participation and membership increases.

To further the goal of providing the best consolidated activities calendar for Tellico Village, the TellicoLife team is revising its subscription levels to make it even easier for clubs and organizations to benefit from TellicoLife.

Key features of the new subscription levels are:

- Blue: \$30/year for up to two calendar entries.
- Bronze: \$60/year for a club home page and up to three calendar entries.
- Silver: \$120/year for a club home page and up to 24 calendar entries.
- Gold: \$300/year for multiple club pages and up to 48 calendar entries.
- Platinum: \$600/year for unlimited use of TellicoLife

An "oasis" is defined as "a pleasant or peaceful area or period in the midst of a difficult, troubled, or hectic place or situation." I often think of Tellico Village as being such a place. The natural beauty, pleasant climate, low cost, and low crime rate combine together to make living in Tellico Village a very pleasant place. Unfortunately, the world around us, even in Monroe and Loudon counties, is often

a very troubled place, which makes the impression of Tellico Village being an oasis in the midst of trouble even more apparent.

Of course, what you define as your oasis may differ from how your neighbors define it. It may be just your house and yard, or your neighborhood, or it could be all of Tellico Village. It might even be the county you live in – Loudon or Monroe – or all of East Tennessee. Some may even say the USA is an oasis in a very troubled world. The point here is that we're all alike in desiring to live in a space that makes us happy, yet we all define this differently.

In contrast, it seems that some people would prefer to act as if they were on an island – defined as "...being isolated or having little or no direct communication with others". I struggle with understanding this approach. It seems like a very lonely place to be and it reminds me of the old saying that "no one on their deathbed says that they wish they had spent more time at work". My point being that it's not the work we do, but the people we impact that is most important. I think we all want to be remembered for helping to make the lives of people around us a little better. This means staying connected to others – whether they be your immediate neighbors, other residents in Tellico Village, or people who live outside the village.

To their credit, many residents of Tellico Village spend a lot of time working to improve the lives of those around them. Whether that be the neighbors down the street, a special interest group here in the village, or helping to solve a need in the wider community - the list is long and varied. Taken from the perspective of living in an oasis, the service of these dedicated individuals demonstrates their willingness to share their good fortune with those who live around them. Sometimes this is sharing of a skill or ability, and sometimes it is to help the less fortunate. Their contribution helps to increase the quality and livability of Tellico Village.

We are all very fortunate to live in such a beautiful place with so much abundance. While living on an island may be safe and secure – particularly in the short term - it leads to isolation and an increasing lack of relevancy. I doubt that any of us want to be considered as irrelevant. Instead, we want to be valued and recognized as a person who counts. This means recognizing that we're living in an oasis, not on an island, and being willing to help those around us. While that may sound simple, it's not. We all have different views as to how to solve problems both in the village and outside. Having problems isn't the problem – that's a natural part of all of us living together. The real problem is not being able to resolve them. It is important to approach how we solve issues by being open, transparent, and committed to finding common ground together. Only then will Tellico Village continue to be the great place to live that it is.
