Protect Yourself from Fraud When Shopping Online

Completing your holiday shopping online is convenient, but it can leave you open to fraud. The holidays are a peak time for thieves to take advantage of consumers that are buying more items and can therefore easily miss fraudulent charges amid a long list of transactions.

When you shop online or from your mobile device, you may be targeted by fraudsters that send you fake emails or texts advertising too-good-to-be-true deals (known as phishing). If you click on an unverified link, you may unknowingly give your credit card number to a thief who can use it to rack up unauthorized charges.

While credit card fraud can happen in numerous ways, there are actions you can take to safeguard your information. There's no way to prevent fraud from happening online, but there are actions you can take to limit your chances of becoming a victim of identity theft.

Here are 7 steps you can follow to protect yourself from credit card fraud during the holidays - and any time of the year.

Review your credit card transactions Monthly

Regularly log into your credit card accounts and check that the transactions listed were made by you or any authorized users. If you notice anything suspicious, contact your card issuer right away to dispute the transaction.

Freeze your credit

A credit freeze restricts access to your credit reports, helping prevent fraudsters from opening new accounts in your name. Make sure you freeze your credit with all three credit bureaus – Experian, Equifax and TransUnion. Note^{*} - Freezing your credit is just a smart, easy, and no cost easy way to protect from someone opening a new account in your name.

Check that websites start with "https"

Before completing a purchase online, check that the URL begins with "https" and that there's a small lock icon that confirms it's a secure site.

Don't answer spam calls or texts

Spam calls are in full force during the holidays, and many thieves have also started texting fraudulent links. Avoid clicking on anything and don't even pick up a spam call. You can block the sender to avoid future messages from them.

Verify deals from social media ads

You may receive targeted ads on social media from companies that you've never heard of boasting amazing deals, but before you click to make a purchase, verify it's legitimate. Do a simple online search for the merchant and read reviews to make sure you can safely complete a transaction.

Don't click on links or open attachments from unknown senders

If you receive an email from an unknown sender, don't click on the link or open the attachment since there's a good chance it's a phishing attempt to get your personal information. Simply delete the message and block the sender.

Opt-out of saving your credit card information

If you want to be extra careful, avoid saving your credit card information on your web browser, phone or loyalty account. This protects unauthorized transactions if someone hacks your account or device.

We hope this helps in some way to protect both Tellico and Kahite residents from experiencing any type of fraud during the upcoming holiday season. And most important, if you encounter any type of fraud incident, please contact the local sheriff's office to report the incident. This may sound trivial. However, it's very important to have an incident report with your name on file in case the offender is apprehended.

Update From Highway Safety Committee



The HOA Highway Safety Committee is currently working on several issues to improve safety on the state highways around Tellico Village. The following are two items.

- 1. Recently the Highway Safety Committee and HOA leadership met with TVA and TDOT representatives to address the need to mow the right of way along Highway 444 on a regular basis. Currently TDOT mows the right of way along Highway 444 from the Tellico Village entrance on the north end down to Highway 72 south end. The area north of the entrance fountain up to Highway 321 is not being covered. As a result of the Highway Safety Committee questions about this unsupported area, TVA has agreed to start mowing this right of way. This should improve the safety of this section of highway north of Tellico Village by opening a wider median strip on each side of the highway in case of emergency. This work has not begun, awaiting final authorization from TVA Knoxville.
- 2. TDOT will be installing traffic counting devices at the intersection of Mialaquo/Cheeyo/Hwy 444. The purpose of these control devices, and the data they collect, will be used to determine the need for installing a traffic light, stop sign or other traffic control measures at that intersection. The study should take a week.

After the study is concluded, TDOT will evaluate the data collected and advise the Highway Safety Committee of their determination based on the data collected.

TDOT is conducting the study at the request of the Highway Safety Committee.

The Highway Safety Committee is made up of three village residents, Ed Wilson, Rick Carlin & Deb Marshall.
