### **Presidents Opening Remarks**

## Tellico Village Volunteer Fire Department: Jerry Dougherty, Chief VFD

- 1. Celebrating their 25<sup>th</sup> year as a 501c organization
- 2. Total call volume for 2024 was 1631, (1320 medical, 311 fire)
- 3. TVFD membership for 2024 was 34-39 active members
- 4. Grant money provided to TVFD provided for the purchase of additional equipment to include 2 new motor vehicles and a boat.
- 5. TVFD has a website; Tellicofd.org; which includes up to date weather information from the National Weather Service and a Link to Loudon County Emergency Communications <a href="https://www.loudontn911.gov">www.loudontn911.gov</a>.
  - a. Loudon County Emergency Communication. (LCEC)
    - LCEC has a service which allows residents to voluntarily provide pertinent information specific to their home and occupants in case of an emergency.
    - ii. information provided by you on the form is provided from the 911 operator when requested by the first responders.
    - iii. Information will not be broadcasted over the radio but by landline only.

- iv. Example of information you can provide on the form includes disabled persons living in home, specific codes for entrance to home, if necessary, etc.
- v. Residents wishing to use this service can access the form through the TVFD website link to LCEC.
- b. Chota Rec Center has new sprinkler system.
- c. KNOX Box System has been installed in all POA facilities.
  - i. System provides TVFD emergency access into POA buildings
- d. MAY 3rd TVFD Open House

### Reserve Funding Bill: John Orr

- 1. Feedback provided through emails to POA and Lowell Russell has been 4:1 positive to continue with legislation for Reserve Funding Bill.
- 2. Approved by the Board

    - i. mostly don't want the government involved in our business
    - ii. doubt the POA Board will ever relinquish collecting the fee

## CEO Report: Chet Pillsbury, CEO

- 1. Reserve study will be done by same company which conducted the last reserve study.
  - a. It usually takes 90 days from start to finish after getting on their schedule.
- 2. Golf: 114K rounds of golf last year; down from the previous year.
- 3. Demographics for golf: 84 % members 16% guests.
- 4. Public Works will be putting fire suppression into the POA administration building which is the last POA building requiring fire suppression.
- 5. Hiring freeze except for Food Service
  - a. Evaluation of each position for need

  - a. Wastewater storage tank being reconsidered
  - b. I&I can only occur at individual homes because we are a closed pressurized system.
  - c. A pilot study has been designed to identify tanks with RDI&I.

- d. Looking for volunteers to participate in pilot study. Contact Scott MacRae.
- e. Looking for any and all other possible solutions to wastewater storage tank.
